The **1<sup>st</sup> round qualifiers' in-center league worksheets, entries and monies** must be submitted to the BCAW office by **December 19, 2008**. Remember also to submit the 1st round qualifiers' **February 1, 2009** averages (or previous week's average if they did not bowl this week or the final league averages if the league ended before this date) no later than **February 6, 2009**.

The **2<sup>nd</sup> round qualifiers' in-center league worksheets, entries, and monies** must be submitted to the BCAW office with their **February 1, 2009** averages (or previous week's average if they did not bowl this week or the final league averages if the league ended before this date) no later than **February 6, 2009**. **No additional entries will be accepted in the BCAW office after Friday, February 13, 2009. **FEES:** For ages 11 & under **as of 8/1/08** The fee is **\$23.00 with every advancing entry**.
