ALL COACHES AND BOWLERS MUST READ RULES

COACHES: If you are no longer actively coaching at the center, please contact the center so the proper personnel may be notified. If coaches would like any materials or information sent directly to them, please indicate your home address on the entry forms otherwise all information will be directed to the center.

PROPRIETORS: If you receive materials and information and are not the youth coach please make sure that information is given to the appropriate people.

The **1st round qualifiers' in-center league worksheets, entries and monies** must be submitted to the BCAW office by **December 20, 2010**. Remember to submit the 1st round qualifiers' **January 31, 2011** average (or previous week's average if they did not bowl that week or the final league averages if the league ended before this date) no later than **February 6, 2011**.

The **2nd round qualifiers' in-center league worksheets, entries, and monies** must be submitted to the BCAW office with their **January 31, 2011** average (or previous week's average if they did not bowl this week or the final league averages if the league ended before this date) no later than **February 6, 2011**. **No entries will be accepted in the BCAW office after Friday, February 12, 2011. In order for us to turn over the materials to the regional houses in a timely manner, this date must be adhered to!** You can also check: www.bowl.com (USBC'S web page)

FEES: For ages 11 & under **as of 8/1/10** the fee is **\$25.00 with every advancing entry**.
For ages 12 & above **as of 8/1/10** the fee is **\$35.00 with every advancing entry**.
